TAMARAC PARK PLAZA II, L.L.C.

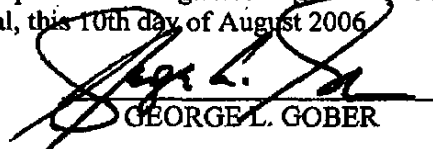
ARTICLE II-ADDRESS

ARTICLE V-PURPOSE

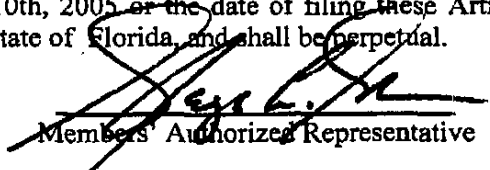
