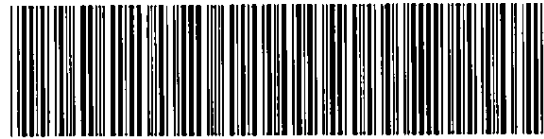

Second: The Articles of Organization were filed on September 1, 2006 and assigned document number L06000086804.


Third: The effective date of this dissolution shall be the date these Articles of Dissolution are filed with the Florida Department of State, Division of Corporations.




