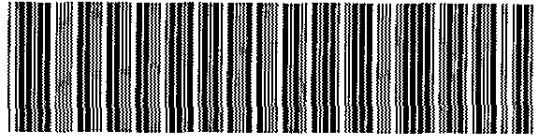

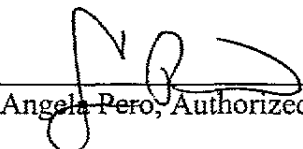

The name of the limited liability company is Pero Vegetable Company, LLC (hereinafter, the "Company").

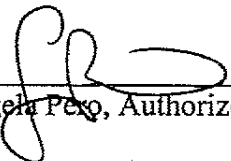
