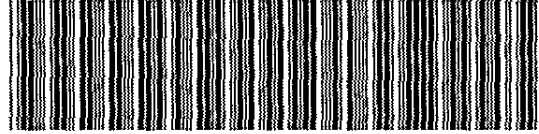

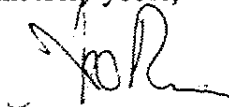

ARTICLES OF ORGANIZATION
OF
R.B. & SONS DEVELOPMENT, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I-NAME

The name of the limited liability company shall be R.B. & Sons Development, L.L.C. ("Company). The principal place of business of the Company in Florida shall be 2505 DeSoto Blvd., Coral Gables, Fl. 33134.

ARTICLE II-PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE III-REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the Company in the State of Florida is Rafael Bonafonte, 2505 DeSoto Blvd., Coral Gables, Fl. 33134.

ARTICLE IV-ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE V-MANAGEMENT

The Company shall be managed by one manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization. The name and address of the initial manager of the company is Rafael Bonafonte, 2505 DeSoto Blvd., Coral Gables, Fl. 33134.

ARTICLE VI-DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles of organization, the regulations of the company, or as provided by law.

ARTICLE VII-TERMINATION OF EXISTENCE

The Company shall be dissolved upon the death, retirement, bankruptcy, or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the Company, unless the business of the Company is continued by the consent of all the remaining members.

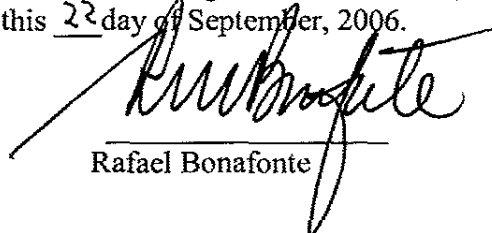
ARTICLE VIII-CAPITAL CONTRIBUTIONS

The members of the company shall contribute to the capital of the company the cash or property necessary to conduct the business of the company.

ARTICLE IX-ADDITIONAL CAPITAL CONTRIBUTIONS

Each member shall make additional capital contributions to the company only on the unanimous consent of all the members or as provided in the regulations.

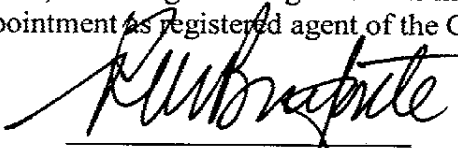
