This amendment is submitted to amend the following:

Article V is hereby amended and restated as follows:

ARTICLE V

NON-PROFIT SOLE MEMBER

The sole purpose of the Company is to own an interest in Colony Park, Ltd. which owns and operates a 130 winit multifamily apartment complex located in Palm Beach County, Florida (the "Property"), decent affordable housing for rent to low- and moderate-income families and in furtherance of the charitable purpose of Community
Housing Corporation of America, inc., a Delaware nonprofit corporation and sole member of the Company (the
"Sole Member"). The Company shall engage only in activities permitted to be engaged in by a "community housing development organization" and which are consistent with the status of its Sole Member as a nonprofit corporation whose income is exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provisions of any future United States internal revenue law) (the "Code"). The Company shall not engage in any activity which is unrelated to the foregoing.

Under no circumstances shall the Company distribute any of its net revenue or earnings (i) to any person or and the state of the same organization other than its Sole Member, or (ii) for a purpose for which its Sole Member may not expend funds. The Company shall not pay compensation to any person or organization in excess of fair and reasonable sums for salary or services received, nor shall any of the Company's revenues be paid or applied in any manner which would constitute private inurement finder Section 501(c)(3) of the Internal Revenue Code. Upon dissolution, all assets of the Company, not of then-existing liabilities, shall be transferred to the Sole Member of the company.
