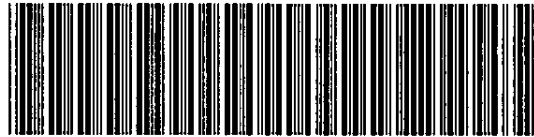

The name of the limited liability company shall be GNP-BA, LLC (the "Company").

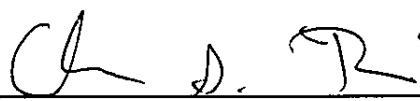
ARTICLE II - ADDRESS
