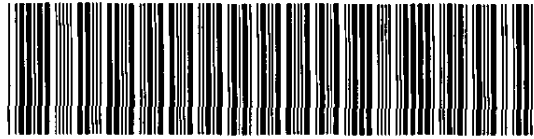

TO
ARTICLES OF ORGANIZATION
OF
NAVARRO DISCOUNT PHARMACIES, LLC
a Florida limited liability company**

(Pursuant to Chapter 605 - Florida Revised Limited Liability Company Act)

FIRST: The name of the Limited Liability Company is Navarro Discount Pharmacies, LLC.

SECOND: The Articles of Organization of the Limited Liability Company were filed on December 26, 2006 and assigned Document No. L06000121860.

THIRD: This amendment to the Articles of Organization is being submitted to amend the following and was adopted by the Limited Liability Company:

Article V of the Articles of Organization of the Limited Liability Company is hereby deleted and replaced in its entirety with new Article V as follows:

"ARTICLE V

The Limited Liability Company is to be managed by Managers and is therefore a manager-managed company. The Managers shall be appointed in accordance with the operating agreement of the Limited Liability Company."

FOURTH: Except as hereby amended, the Articles of Organization of the Limited Liability Company shall remain unchanged.

FIFTH: The Articles of Amendment shall be effective upon their filing with the Florida Department of State.
