ARTICLES OF ORGANIZATION

OF

EASY SCREEN USA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **EASY SCREEN USA, 正**("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2123 Whitefield Park Avenue, Sarasota, Florida 34243 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

ARTICLE 10 - INDEMNIFICATION

The Company shall indemnify managers and/or members of the Company who was wholly successful, on the merits or otherwise, in the defense of any proceeding to which the managers and/or members was a party because the managers and/or members is or was a manager and/or member of the Company against reasonable attorney fees and expenses incurred by the managers and/or members in connection with the proceeding. If any word, clause or sentence of the foregoing provisions tegarding indemnification or advancement of the attorney fees or expenses shall be held invalid as contrary to law or public policy, it shall be severable and the provisions remaining shall not be otherwise affected. All references in these Articles of Organizations to "member", "manager", "employee" and "agent" shall include the heirs estates, executors, administrators and personal representatives of such persons.
