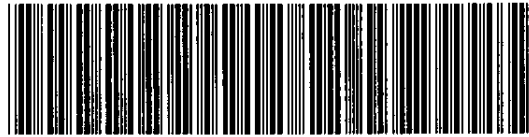

TIGER CONCRETE AND SCREED, LLC**



SECOND: The Articles of Organization are hereby amended to include the following Article V:


