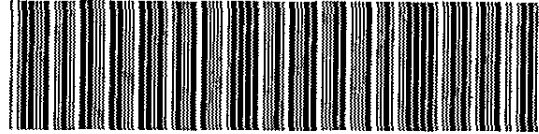


Article 1. Name: The name of the Limited Liability Company shall be Running Wild, LLC and will operate under the laws of the State of Florida.

However should any partner agree to leave the partnership for any of the above reasons, except being expelled, within five years of the date of registration the partners have agreed that the value of their interest will only be \$100 unless all three partners agree to a higher value.


