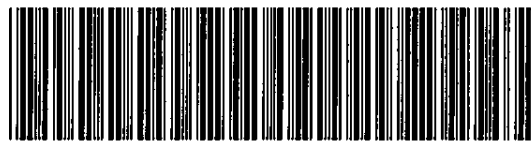



This statement is incorrect because it fails to state that "105" is "Suite # 105." A client may find this confusing


Please also amend Article III so that it provides:
