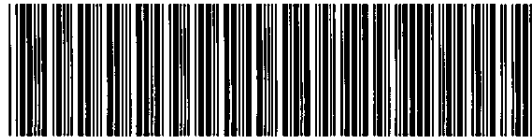




Article IV - Management
