**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
QUALITY VENDOR MANAGEMENT, LLC**

Pursuant to the provisions of Section 608.411 of the Florida Limited Liability Company Act, **QUALITY VENDOR MANAGEMENT, LLC** adopts the following Articles of Amendment to its Articles of Organization:

FIRST: The name of the limited liability company is **QUALITY VENDOR MANAGEMENT, LLC** (the "Company").

SECOND: The Articles of Organization of the Company were filed with the Florida Department of State on February 27, 2007, under Document Number L07000022362.

THIRD: Article I of the Company's Articles of Organization is hereby amended and restated in its entirety as follows:

"ARTICLE I - NAME

The name of this limited liability company is **QUALITY LABOR MANAGEMENT, LLC** (the "Company")."

FOURTH: Article IV of the Company's Articles of Organization is hereby amended and restated as follows:

"ARTICLE IV - MANAGEMENT

The Company will be managed by one or more managers and, therefore, it is a *manager-managed* Florida limited liability company."
