FIRST: The Articles of Organization were filed on March 12, 2007 and assigned document number L07000026512.

SECOND: This amendment is submitted to amend the following:

THIS AMENDING AGREEMENT dated this 24th day of April, 2007

BETWEEN:

Alejandro R. Gaviria

OF THE FIRST PART

-AND-

Jose M. Romero

OF THE SECOND PART

-AND-

Martha L. Corrales

OF THE THIRD PART

-AND-

Dolly Ricaurte

OF THE FOURTH PART

Background

- A. Alejandro R. Gaviria, Jose M. Romero, Martha L. Corrales and Dolly Ricaurte (the "parties") entered into the contract (the "contract") dated April 24th, 2007, for the purpose of transfer percentage interest from existing member to new member Mrs. Dolly Ricaurte with a required initial capital contribution of \$30,000.
- B. The Parties desire to amend the Contract on the terms and conditions set forth in this Amending Agreement (the "Agreement").
- C. This Agreement is the first amendment to the Contract.

IN CONSIDERATION OF the Parties agreeing to amend their obligations in the existing Contract, and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree to keep, perform, and fulfill the promises, conditions and agreements below:

Amendments

1. The Contract is amended as follows:
 - a. Exhibit A of Article 2.1 **Initial Capital Contributions and Membership Interests** is hereby amended. First party member Mr. Alejandro R. Gaviria is transferring 47.50% percentage interest of his 50% percentage interest to fourth party member Mrs. Dolly Ricaurte. This fourth party member is required to contribute an initial capital contribution of \$30,000USD. Second Party member Mr. Jose M. Romero is transferring 1.25% percentage interest of his 25% percentage interest to first party member Mr. Alejandro R. Gaviria. Third party member Mrs. Martha L. Corrales is transferring 1.25% percentage of interest of her 25% percentage of interest first party member Mr. Alejandro R. Gaviria.
 - b. The following provision is hereby added immediately after the ending clause in section 2.2 of the Operating Agreement: "All Party members have hereby agreed unanimously that a subsequent contribution made by only the first party member Mr. Alejandro R. Gaviria in the amount of \$12,000USD is required. This payment must be made in full in order for the first party member to be eligible to receive 5% percentage of interest from each member: second party member – Mr. Jose M. Romero, third party member – Mrs. Martha L. Corrales, fourth party member – Mrs. Dolly Ricaurte. These are the members listed in this Amending Agreement."
 - c. The following provision is hereby added immediately after section 2.5 of the Operating Agreement and should read like this: "**2.6 Failure to make Contributions.** If a member fails to make a required capital contribution within the time agreed for a member's contribution, the remaining members may, by unanimous vote, agree to reschedule the time for payment of the capital contribution by the late-paying member, setting any additional repayment terms, such as a late payment penalty, rate of interest to be applied to the unpaid balance, or other monetary amount to be paid by the delinquent member are refunded promptly by the LLC to the member after the decision is made to terminate the membership of the delinquent member.

2. Article V is amended as follows:

e. The following provision is hereby added immediately after clause 5.4 of the operating agreement and should read like this: "5.5 Tax Treatment. This LLC shall be treated as a S-Corporation for income tax purposes. The tax year of this LLC shall be January 1 through December 31 of each year. The LLC shall use the accrual basis method of accounting."
