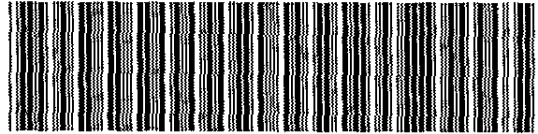

CONTRACTING DEBTS

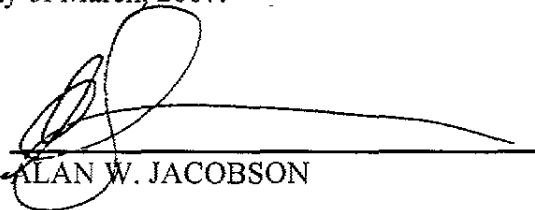
The Manager shall be authorized to incur any liability on behalf of the limited liability company.
