The Company is to be a manager managed company. The name and address of the initial manager of the Company are:

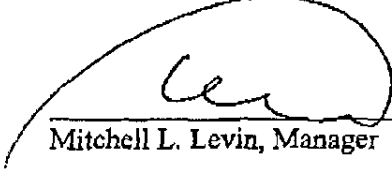

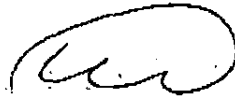
