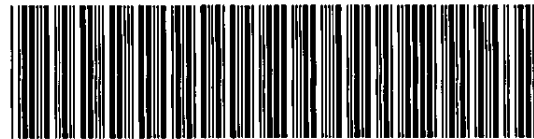

ARTICLE II - ADDRESS


The mailing address and street address of the principal office of the Company is 280 Parkside Circle, Port St. Joe, Florida 32456.
