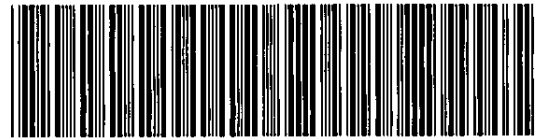

**ARTICLES OF ORGANIZATION  
OF  
AVANTI ENERGY, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, pursuant to Chapter 608, Florida Statutes, as amended, hereby makes, acknowledges, and files the following Articles of Organization (the "Articles").

**ARTICLE I.  
NAME**

The name of this limited liability company is Avanti Energy, LLC (the "Company").

**ARTICLE II.  
MAILING ADDRESS & STREET ADDRESS**

The mailing address, street address and principal place of business of the Company shall be 777 South Harbour Island Boulevard, Suite 140, Tampa, Florida 33602.

**ARTICLE III.  
REGISTERED AGENT AND OFFICE**

**ARTICLE IV.

The company is to be a member-managed Company.

**ARTICLE V.

**ARTICLE VI.  
INDEMNIFICATION**

The Company shall, to the full extent permitted by Chapter 608 of the Florida Statutes, as amended from time to time, indemnify and advance expenses to, and may purchase and maintain insurance on behalf of, all persons whom it may indemnify pursuant thereto. The indemnification provided by this Article VI shall not limit or exclude any rights, indemnities or liabilities to which any person may be entitled, whether as a matter of law, under the operating agreement of the Company, by agreement or otherwise.


**ARTICLE VII.  
DURATION**

The Company shall commence its existence as of April 18, 2007. The period of duration for the Company shall be perpetual.

**ARTICLE VIII.  
AMENDMENT**

The Articles may be amended only by the unanimous consent of all the members.


