"ARTICLE I"

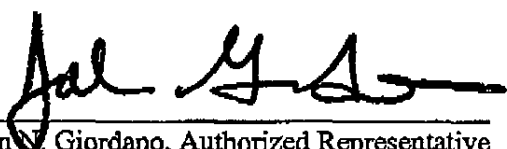
COMPANY NAME AND ADDRESS
