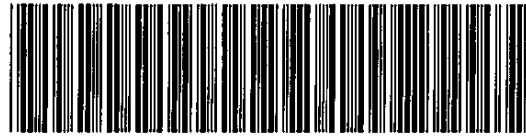


Article VIII - Miscellaneous



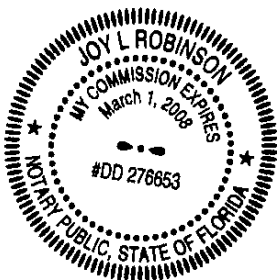
