

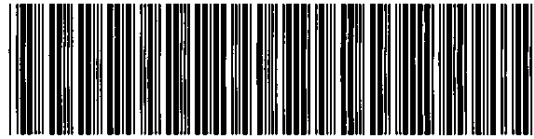

ARTICLE I

NAME

The name of this limited liability company (the "Company") shall be **FLORIDA PATIENTS' BENEFITS, LLC** and its mailing address is 3222 Corrine Dr., Suite E, Orlando, Florida 32803, and its principal place of business is 3222 Corrine Dr., Suite E, Orlando, Florida 32803.

ARTICLE II

COMMENCEMENT OF EXISTENCE


