ARTICLES OF ORGANIZATION OF

444 Biscayne Boulevard, LLC.

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statute 608 entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such Company:

ARTICLE NAME
