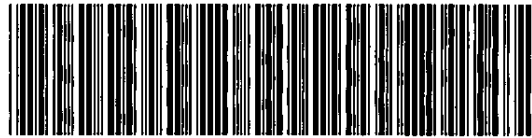

**SECOND:** This amendment is submitted to amend the following:

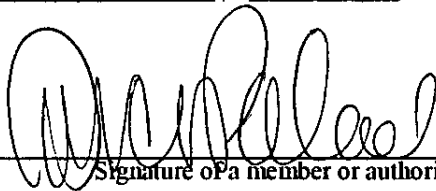
American Dream Makers, LLC held a meeting of the Managing Members on July 29th, 2007 at 12:00 PM.
