The undersigned, being authorized to execute and file these Articles, hereby certifies that:

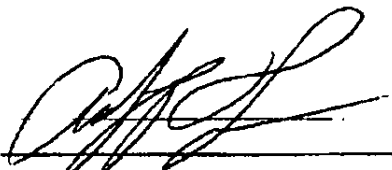
FIRST: The name of the Company shall be "TATE'S LANDING, LLC".

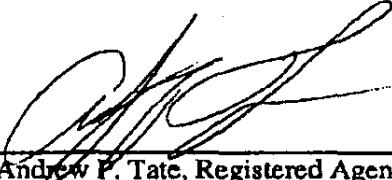
