The name of this limited liability company ("Company") is: **1331, LLC.**

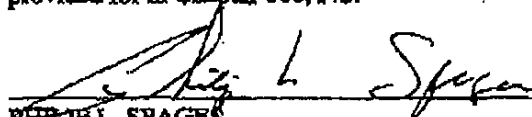

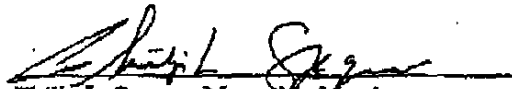
