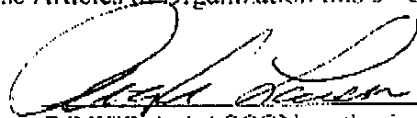
ARTICLE III

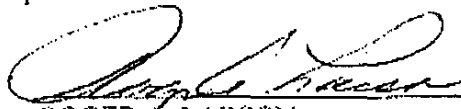
