ARTICLES OF ORGANIZATION

OF

PEBB ENTERPRISES CITRUS PARK, LLC

THE UNDERSIGNED, pursuant to the provisions of Chapter 608 of the Florida

Statutes, for the purpose of forming a Florida Limited Liability Company (the "Company")

under the laws of the State of Florida does set forth the following:

1. NAME The name of the Company is:

PEBB ENTERPRISES CITRUS PARK, LLC

- 2. **PERIOD OF DURATION** In accordance with Section 608.409(1) of the Florida Limited Liability Company Act ("Act"), the term of existence shall begin the date these Articles are filed and its duration shall be perpetual, unless other dissolved or terminated by the unanimous written agreement of all members or pursuant to an event described in paragraph 7 of these Articles of Organization.
- 3. PURPOSE

 The purpose for which the Company is organized is solely limited to (I) owning, holding, selling, leasing, transferring, exchanging, operating and managing a parcel of real property (referred to herein as the "Property"), (ii) entering into loan documents with a bank or other institutional lender (the "Lender") for the acquisition of the Property (the "Loan"), (iii) refinancing the subject property in connection with a permitted repayment of Lender's loan, and (iv) transacting any and all lawful business permitted by the laws of the State of Florida, necessary and appropriate to accomplish the foregoing. The Company shall have all of the powers vested in a Limited Liability Company organized and existing by virtue of such laws.

- 8. MANAGEMENT The Company is to be managed by a Manager.

- 9. CERTAIN ACTIONS REQUIRING UNANIMOUS VOTE: The unanimous vote of the Company's Members shall be required in order to take any of the following actions:
 - A. Filing a petition or consent to a petition seeking reorganization, arrangement, adjustment, winding-up, dissolution, composition, liquidation or other relief on behalf of the Company of its debts under any federal or state law relating to bankruptcy.
 - B. Seeking or consenting to the appointment of a receiver, liquidator, assignee, trustee, sequestrator, custodian or any similar official for the Company or a substantial portion of its properties.
 - Making any assignment for the benefit of the Company's creditors
 - D. Taking any action in furtherance of any of the foregoing.

10. SEPARATENESS ("SPE") PROVISIONS: The Company shall not:

- merge into or consolidate with any other entity, or dissolve, terminate,
 liquidate in whole or in part, transfer or otherwise dispose of all or
 substantially all of its assets or change its legal structure;

- e. incur any debt, secured or unsecured, direct or contingent (including guaranteeing any obligation), other than (A) the loan from Lender, (B) trade and operational indebtedness incurred in the ordinary course of business with trade creditors, provided such indebtedness is (1) unsecured, (2) not evidenced by a note, (3) on commercially reasonable terms and conditions, and (4) due not more than sixty (60) days past the date incurred, and/or (C) financing leases and purchase money indebtedness incurred in the ordinary course of business relating to personal property at the subject.
