1. The name of the limited liability company is Beth A. Grieninger, MD, LLC (the "Company") and its document number is L07000074489.

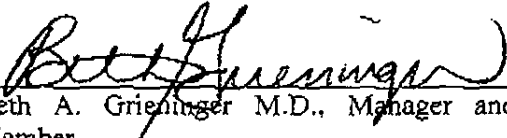
2. The effective date of this dissolution shall be the date these Articles of Dissolution are filed with the Florida Department of State.

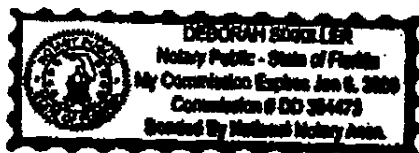
