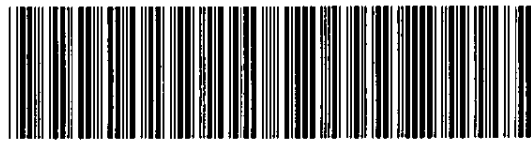

Pursuant to Section 608.411 of the Florida Statutes, the undersigned hereby determines and acknowledges that the articles set forth below shall amend and restate the existing Articles of Organization (the "Existing Articles") of South M.M. LLC, a Florida limited liability company (the "Company"), in all respects.

ARTICLE I - Name
