ARTICLES OF ORGANIZATION OF 6900 H.L.C., L.L.C., a Florida limited liability company

The undersigned, being the managing member of a limited liability company to be organized under the Florida Limited Liability Company Act, adopts and submits the following Articles of Organization for such limited liability company:

ARTICLE I NAME

The name of the limited liability company (the "Company") shall be 6900 HSL.C., LL.C, a

The initial number of managers of the Company shall be one (1). The number of managers may be decreased or increased in accordance with the terms of the Operating Agreement and Regulations.
