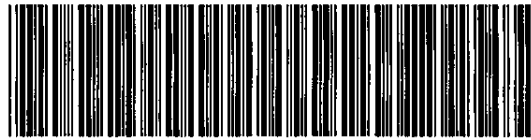

**ARTICLES OF ORGANIZATION
OF

The undersigned hereby certifies that his in one of the Members who are forming a limited liability company under Chapter 608, Florida Statutes, providing for the formation, rights, privileges, and immunities of limited liability companies for profit and the following Articles of Organization are hereby adopted.

**ARTICLE I.
Name**

Restrictions of Membership;
Right to Admit Additional Members**

Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the Limited Liability Company, the remaining members shall have the right to continue the business of the Limited Liability Company upon the affirmative vote of a majority of the remaining members.

**ARTICLE VIII.
Management**

Management of the Limited Liability Company is reserved to its managing members and is, therefore, a member-managed company.
