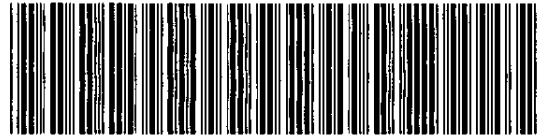

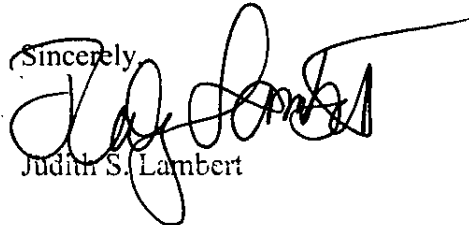

**ARTICLE VI**

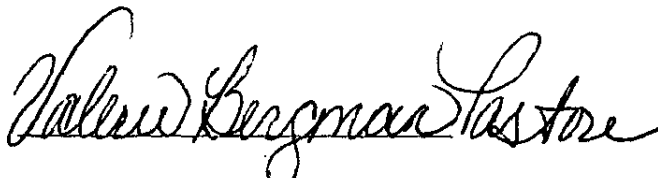
All remaining property and assets have been distributed to the members in accordance with their respective rights and interests.

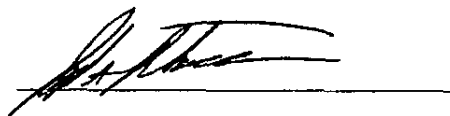
