

#### ARTICLES OF ORGANIZATION

The Member who desires to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, by and through his authorized representative, does hereby adopt the following Articles of Organization and certify:

#### **ARTICLE I: NAME**

The name of the limited liability company is Vicini Properties, LLC (the "Limited Liability Company").

#### ARTICLE II: ADDRESSES

The mailing address of the Limited Liability Company is 529 Dynamic Drive, Garner, North Carolina, 27529. The street address of the principal office of the Limited Liability Company is also 529 Dynamic Drive, Garner, North Carolina, 27529.

#### **ARTICLE III: DURATION**

#### ARTICLE IV: PURPOSE

The purpose for which the Limited Liability Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE V: REGISTERED AGENT AND OFFICE

#### ARTICLE VI: OPERATING AGREEMENT

Any Operating Agreement (as defined in Section 608.402(24), Florida Statutes) relating to the Limited Liability Company must be in writing and signed by all of the Members.

The Limited Liability Company shall be conducted, carried on and managed by at least one (1) Managing Member, who shall be elected annually by the Members of the Limited Liability Company in the manner prescribed by and provided in the Operating Agreement, if any, of the Limited Liability Company, or the laws of the State of Florida. The Managing Member shall serve in this capacity until the first annual meeting of the Members or until his successor(s) is duly elected and qualified.

#### **ARTICLE VIII: REGULATIONS**

The power to adopt, alter, amend or repeal the Operating Agreement of the Limited Liability Company shall be vested in the Members of the Limited Liability Company.

#### ARTICLE IX: LIMITATION ON AGENCY AUTHORITY OF MEMBERS

Pursuant to Section 608.4235 of the Florida Limited Liability Company Act, no Member of the Limited Liability Company shall be an agent for the Limited Liability Company solely by virtue of being a Member, and no Member shall have authority to incur debt or contractual liability on behalf of the Limited Liability Company solely by virtue of being a Member.
