Operating Agreement

Accordingly, the Company shall be a manager-managed company. Any reference to a member of the Company using the term "managing member" or "member-manager" (or any similar term or title) shall be deemed a reference to such member in the capacity as a manager of the Company, provided that such member otherwise has been duly appointed, designated or elected and otherwise qualifies to serve as a manager.

The Company's existence shall commence on and as of August 20, 2007, if these Articles of Organization are filed with and by the Florida Department of State within five (5) business days after such date, and otherwise on and as of the date of such filing.
