**ARTICLES OF ORGANIZATION FOR
FLORIDA LIMITED LIABILITY COMPANY**

ARTICLE I - Name

The name of the limited liability company is ROG, LLC.

ARTICLE II - Address

ARTICLE IV - Purpose


