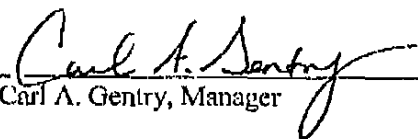
ARTICLE III

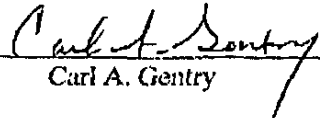
