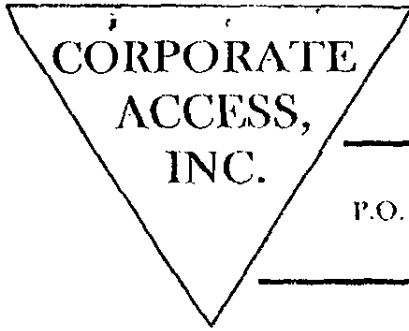

The Villages, Florida 32162."

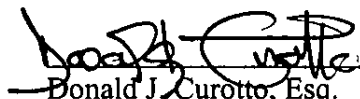
