The name of the professional limited liability company created hereby (the "Company") is **The Grant Law Group, P.L.**

ARTICLE II - Address

ARTICLE VI - Membership Units

The total number of membership units authorized to be issued by the Company shall be 10,000 units. Each of the said units shall entitle the holder thereof to one (1) vote at any meeting of the members. All or any part of said units may be paid for in cash, in property, or in labor or services at a fair valuation to be fixed by the managers of the Company at a meeting called for such purposes. All membership units then issued shall be paid for and shall be nonassessable. The Company elects to have preemptive rights.

ARTICLE VII - Ownership

The names and addresses of the members of the Company shall be maintained by the Company and kept with its business records.

ARTICLE VIII - Admission of Additional Members

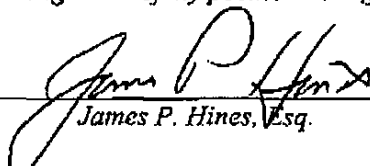
The members may admit additional members in accordance with the operating agreement pertaining to the Company.

ARTICLE IX - Registered Agent, Registered Office, and Resident Agent's Signature

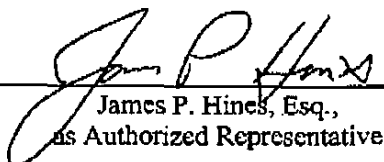
