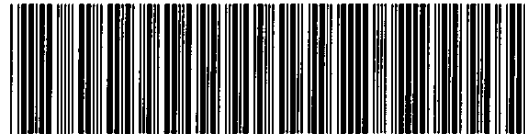

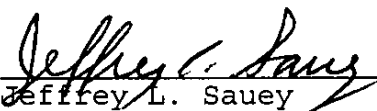

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name of the limited liability company (hereinafter referred to as the "Company") is "RUSSELL FAMILY INVESTMENTS COMM, LLC."

ARTICLE II - Address

ARTICLE III - Duration

Pursuant to Section 608.4235 of the Florida Limited Company Act, no member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability for the Company solely by virtue of being a member.
