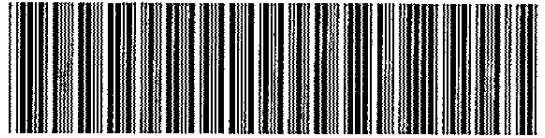

Name of Company

Business of Organization
