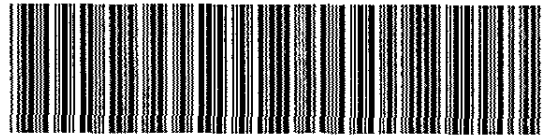

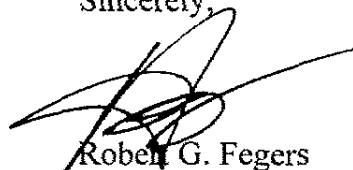

The Limited Liability Company is to be managed as set forth in the Operating Agreement. The initial managing member is Benjamin R. Van Ryswyk, Jr.

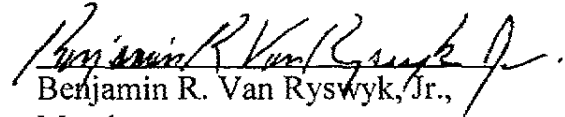

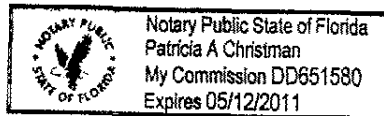
