ARTICLE VIII

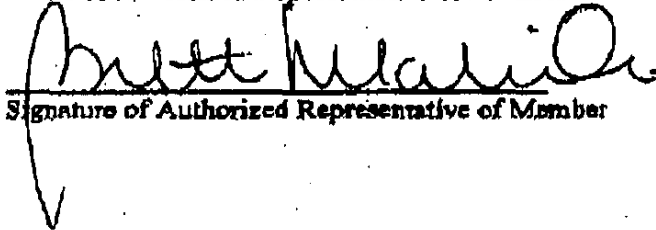

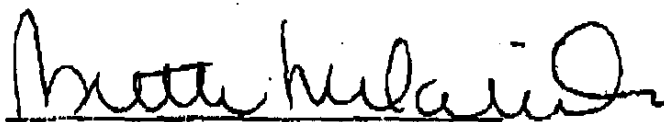
