AGREEMENT TO SELL BUSINESS

Agreement made this 3 day of March, 2009 by and between Talmadge Brock Mclean (herein "seller" and currently holds 50% interest) and Juan Carlos Morales (herein "buyer" and currently holds 50% interest) partners in Plan B Building Maintenance, LLC., a Florida Limited Liability Company.

Whereas the Seller desires to sell and the Buyer desires to buy the 50% share of seller's interest in business known as Plan B Building Maintenance, LLC., a Florida Limited Liability Company, who's address is 981 Hwy 98E Suite 3-256, Destin, FL 32541 and assets thereof. The parties agree and covenant as follows:

1. The total purchase price for all fixtures, furnishings, contracts and equipment is \$ 1.00 Dollar payable as follows and with the following conditions:

(a) \$ 1.00 paid in cash upon execution of this contract.

2. Any property belonging to the company shall be transferred to the buyer and be conveyed by a standard Bill of Sale form executed by the seller for no additional monies than agreed upon herein.

3. The Buyer, at execution of this contract shall hold 100% shares of Plan B Building Maintenance, LLC. with the following obligations to the Seller:

(a) Seller shall be retained as a subcontractor to Plan B Building Maintenance LLC. at the current pay schedule and rate of \$600.00 per week for a period of no more than six months after execution of this contract.
