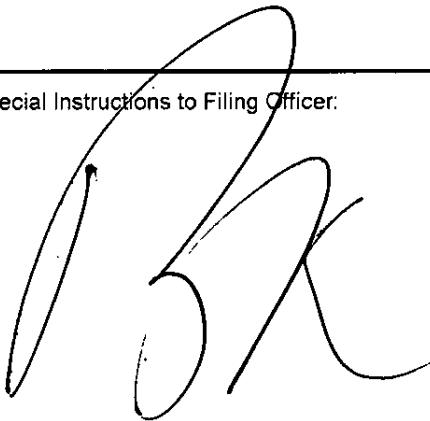

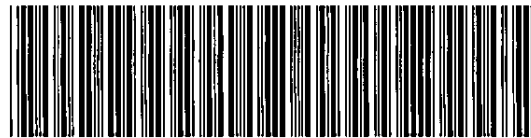

NAME
