AGREEMENT AND PLAN OF MERGER OF

ACTIVE DIMENSION, LLC AND CONCEPTRIX, LLC

THIS AGREEMENT AND PLAN OF MERGER (the "Agreement") is entered into on December 2011, by and between Active Dimension, LLC, a Florida limited liability company (the "Merging LLC"), and Conceptrix, LLC, a Tennessee limited liability company (the "Surviving LLC"), pursuant to Tenn. Code Ann. § 48-249-101. et seq and Sections 608,438 et, seq. of the Florida Limited Liability Company Act

WITNESSETH:

WHEREAS, the Merging LLC has elected to contribute all of its assets and properties to the Surviving LLC by merger in exchange for membership interests in the Surviving LLC, which will be distributed to the members of the Merging LLC; and

WHEREAS, the respective Members of the Merging LLC and the Surviving LLC have approved the merger of the Merging LLC with and into the Surviving LLC (the "Merger") pursuant to the terms and conditions of this Agreement: and

WHEREAS, following the Merger, the separate existence of the Merging LLC shall terminate.

NOW, THEREFORE, in consideration of the foregoing, the mutual promises and covenants set forth below, and other good and valuable consideration, the receipt, sufficiency and adequacy of all of which is hereby acknowledged, the Merging LLC and the Surviving LLC agree as follows:

- Parties to the Merger. The names of the entities planning to merge are Active Dimension, LLC, a limited liability company organized under the laws of Florida, and Conceptrix, LLC, a limited liability company organized under the laws of Tennessee.
- 2. <u>Surviving Entity</u>. Conceptrix, LLC shall be the surviving entity of the Merger, and the separate existence of Active Dimension, LLC shall cease.
- 3. Effective Time. The Merger shall be effective on December 31, 2011 at 11:59 P.M. (the "Effective Time").
- 4. Terms and Conditions. The terms and conditions of the Merger are that: (i) at the Effective Time and pursuant to the Tennessee Revised Limited Liability Company Act and the 2011 Florida Statutes, the Merging LLC shall be merged with and into the Surviving LLC, and the Surviving LLC shall survive the Merger, (ii) the name of the Surviving LLC shall continue to be Conceptrix, LLC; and (iii) the separate existence and organization of the Merging LLC shall cease. Title to all properties, real, personal and mixed, tangible and intangible, including goodwill, trademarks, trade names, copyrights, patents, trade secrets, and other intellectual property, owned by the Merging LLC at the Effective Time of the Merger shall be vested in the Surviving LLC at that time and all other assets and all liabilities of the Merging LLC shall become assets and liabilities of the Surviving LLC as of the Effective Time.

- 5. 47 Issuance of Membership Interests. At the Effective Time, all of the assets of the Merging LLC shall be contributed to the Surviving LLC, the members of the Merging LLC shall each receive membership interests in the Surviving LLC in exchange for their interests in the Merging LLC, and the membership interests of the Merging LLC shall then be terminated.
- 6. <u>Miscellaneous</u>. This Agreement contains the entire agreement between the parties hereto with respect to the transactions contemplated by this Plan of Merger and supersedes all prior written or unwritten arrangements or understandings with respect thereto. All parties represent that they are not relying on any representation, statement, or action by any other party except as expressly stated herein. This Plan of Merger may be executed in any number of counterparts, and each such counterpart hereof shall be deemed to be an original instrument. This Plan of Merger shall be governed by and in accordance with the substantive, internal laws of the State of Tennessee. The parties agree that they have jointly prepared this Agreement. This Agreement may not be modified, amended, or revoked, except in a writing signed by all parties. This provision may not be orally waived.
