ARTICLES OF ORGANIZATION OF TOOJAY'S ALTAMONTE, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be TooJay's Altamonte, L.L.C. ("Company").
