**ARTICLES OF ORGANIZATION  
FOR

**ARTICLE I  
NAME**

The name of the limited liability company is MARC-MICHAELS DESIGN, QATAR, LLC.

**ARTICLE II  
INITIAL PRINCIPAL OFFICE**
