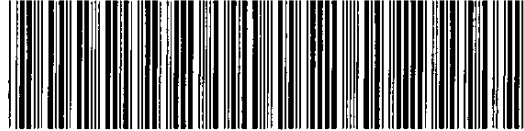

**ARTICLE I.  
NAME OF LIMITED LIABILITY COMPANY**

The initial registered agent of the limited liability company shall be the following named person at the following address:

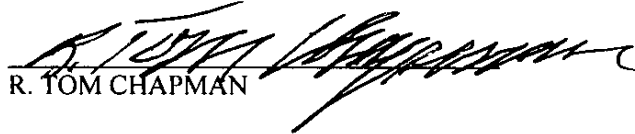
