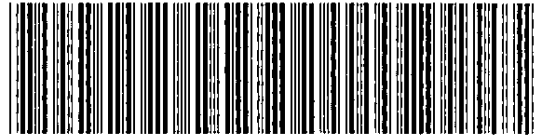

- FIRST: This Amended and Restated Articles of Organization amends and restates the Articles of Organization of **Parrott (4) LLC, a Florida Limited Liability Company.**

- THIRD: The Articles of Organization of **Parrott (4) LLC** are hereby amended and restated as follows:

The mailing address and street address of the principal office of the Limited Liability Company is **131 Eastpark Drive, Celebration, FL 34747.**

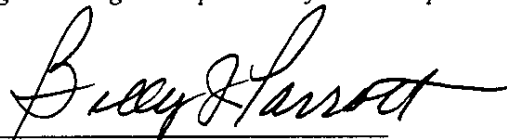
**Article III**
