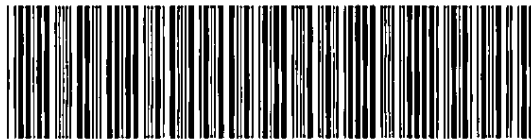



PLAN OF CONVERSION

This Plan of Conversion, effective as of 1 Jan 2021 (the "Effective Date") is hereby adopted by Ecosystem Renewal, LLC., a Florida limited liability company (the "Converting Company") in order to convert to a Louisiana limited liability company (the "Converted Company"). Accordingly, the undersigned hereby certifies the following:

1. The name of the Converting Company is Ecosystem Renewal, LLC. The name of the Converted Company will be Ecosystem Renewal, LLC.

2. The Converting Company is currently a Florida limited liability company. Following the Effective Date, the Converted Company will be a Louisiana limited liability company and continue its existence under the laws of the state of Louisiana

3. The Plan of Conversion for the conversion of the Converting Company from a Florida limited liability company to a Louisiana limited liability company (the "Plan of Conversion"), has been approved by the sole member of the Converting Company, who holds 100% of the outstanding membership interest, after waiving notice of a meeting as required by Fla. Stat. §605.1043(4).

4. The manner and basis of converting membership interests of the Converting Company into membership interests of the Converted Company are as follows:

- a. Holcomb Resources, Inc. owns 100% of the membership interests in the Converting Company:
- b. The membership interest of Holcomb Resources, Inc. will, without any other action, be converted on the Effective Date into one hundred (100%) percent of membership interest of the Converted Company.



BE IT KNOWN, on this 31st day of DEC, 2020, personally came and appeared before me, Notary Public, the undersigned, of the full age of majority, who declared to me, in the presence of the undersigned competent witnesses, that, availing himself of the provisions of the Louisiana Liability Company Law, LSA R.S. 12:1301, et. seq., he does hereby organize a limited liability company pursuant to that law, in accordance with the following articles of organization:

ARTICLE I.

NAME

LIMITATION OF LIABILITY





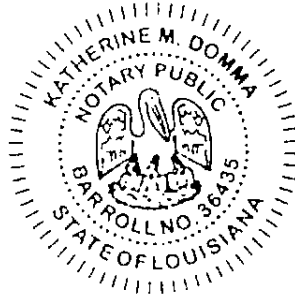
